Payroll: The clerk informed the council about some issues with payroll. The council agreed to hire an external payroll provider, and authorised the clerk to arrange it if before the next meeting, up to the cost of £120 per year. The clerk was asked to come back to the council if the quotes were any higher than that. **Action 18/32.1**

18/33 **Planning:** No planning applications.

18/34 **Traffic Management and Road Safety:** Cllr Scordellis requested a breakdown of costs for Back Lane and Poplars Lane, and the reply was unsatisfactory.

The speed limit review panel meeting was cancelled, and has now been re-scheduled for 6 March.

Cllr Wilson spoke with residents at 15 Glebe Close regarding the pole the VASID sign, and they had no issue with it.

Highways are no longer able to pre-fund the traffic calming measures. Cllr Scordellis spoke with Steve Ellis at Daventry, to ask about the S106 money, and was informed a quarter of it for the four villages should be available in April 2018, of which Holcot would be entitled to 25%. Cllr Scordellis proposed that if the money becomes available, he should spend it on the VASID sign (£2500-£3000). The cost of the posts are still unknown.

Cllr Scordellis informed the council that each VASID pole will only be used around once every 18 months – 2 years.
