18/73 **Correspondence**:

- a) Jane Parry: email asking for more information for the green space application. Cllr Gunnett offered to assist the clerk and the clerk will set up a meeting. Action 18/73.1
- b) Walgrave Parish Council: email regarding the prior approval application for the Land off Walgrave Road. The council asked the clerk to reply to Walgrave PC to thank them for the copy of the email to DDC, and to inform them their comments have been noted. *Action 17/73.2*
- c) Walgrave Parish Council: email asking if Holcot are planning on taking action regarding the removal of the No. 10 bus service offpeak hours. The council asked the clerk to reply to say that given the financial constraints of the County Council, and the very infrequent use of the service, the Parish Council have decided not to challenge the change. Action 17/73.3
- 18/74 **Crossroads maintenance:** After discussing the possibilities at length, Cllr Walker proposed that the council protect the crossroads green space with a landscaping scheme (planters etc), and also protect the area outside of No.2 Brixworth Road. The council agreed with the proposal.

The next step is to plan the scheme and design the works. Cllr Gunnett & Cllr Buckle will prepare a proposal for the next meeting. *Action 18/74.1*

The clerk will make enquiries with Highways about authorisation for planters (once the work has been decided). *Action 18/74.2*

- Annual Parish Meeting planning: The meeting will take place on Monday 21 May in the Church room starting at 6.30 p.m. Cllr Shephard has sent her apologies for the Annual Parish Meeting, but has sent her report to the clerk. The clerk will create a standard agenda, with the addition of the speed limit approach. *Action 18/75.1*
- 18/76 **Speed Limit Approach:** The council agreed to add this to the Annual Parish Meeting agenda, so they can receive guidance from the electorate.

18/77 **Lighting**:

a) The council agreed on the replacement of the old concrete column on Glebe Close, along with a new lantern. Total cost £999 excluding VAT. The clerk will contact EON. *Action 18/77.1*

- b) The council authorised the cost of a new lantern for outside of 12 Moulton Road the next time it fails. The cost for this will be £399 excluding VAT, and the clerk will order it when it next goes out.
- Planning: The council discussed the planning application below at length, and agreed that it had been objected to in the past for various reasons that have not changed. The Council determined that further consultation with neighbours was necessary. The Council agreed to delegate the final response to Cllr Buckle. Cllr Buckle will consult neighbours and get back to the clerk with a response for Daventry before the deadline of 24 April. *Action 18/78.1*

- 18/81 Playing Field: Cllr Fountain presented the plan of the intended improvements for the playing field. The council authorised 'Phase 1' of the plan which is to install an adventure path. The Friends of Holcot Playing Field will transfer all raised funds to the Parish Council before payment of the adventure path is due. *Action 18.81.1*

The council authorised the removal of the wooden see-saw and the wooden beam. Cllr Gunnett said he will ask the 'Friends of Holcot' to do the work. *Action 18.81.2*

The council requested that the 'Friends of Holcot Playing Field' prepare a shopping list of the items of equipment that are planned to be installed as and when the funds come in, and also a phase plan for completion. This plan is not required until Phase 1 completion. *Action* 18/81.3
